Based on the result of 2nd stage written examination held on 18.08.2013 for the post of ECRC, Goods Guard, Jr. Account Assistant cum Typist, Sr. Clerk cum Typist and Assistant Station Master, Category No. 3, 4, 5, 6 and 7 respectively of CEN No. 03/2012, Typing Skill Test held on 19.02.2017 to 20.02.2017 for the post of Jr. Accounts Assistant cum Typist & Sr. Clerk cum Typist, Category No. 05 and 6 respectively: and Aptitude Test held on 21.02.2017 for the post of Assistant Station Master, Category No. 7 of CEN No. 03/2012 followed by Verification of Certificates and Identity held from 10.07.2017 to 15.07.2017 and on 31.07.2017.
